FERC holds public meetings on Yadkin relicensing

Officials from the Federal Energy Regulatory Commission (FERC) visited the Yadkin Project in January as part of the federal relicensing process. A two-day site visit provided FERC representatives with a tour of the Yadkin lakes, dams and powerhouses. That was followed by a series of meetings that focused on environmental issues that will be addressed by the commission in an Environmental Impact Statement.

Several hundred people turned out for public meetings held in Lexington on January 23 and Albemarle on January 24. At the first meeting, many homeowners and recreation users voiced support for the extended recreation season and drought management plan proposed by Alcoa-Yadkin, but encouraged FERC to consider keeping more water in High Rock Lake during the winter drawdown period. Concerns about the possible environmental impact from Alcoa's Badin Works smelter were raised at the second meeting. At a meeting with representatives from state and federal agencies, local governments and environmental interest groups, there was strong support for the water quality and environmental enhancements included in Alcoa's proposed relicensing agreement.

FERC will accept written comments from the public through Monday, February 26.

Alcoa nears completion of Relicensing Settlement Agreement

The work to develop a comprehensive Relicensing Settlement Agreement is expected to be finalized in the next several weeks. Alcoa-Yadkin has been working closely with 27 stakeholder groups representing state and federal agencies, local governments, environmental organizations and homeowners groups to develop a collective recommendation regarding the future management of the Yadkin Project.

A signed agreement will be formally submitted to FERC in March 2007.

"The relicensing agreement reflects the involvement, input and influence of many different organizations and represents a true balance of interests. We have worked hard to develop an agreement that offers substantial benefits for everyone involved," said Gene Ellis, licensing and property manager at Alcoa-Yadkin. "If FERC adopts the settlement agreement, people can expect to see more water in High Rock Lake, more recreational opportunities, stronger environmental protections, long-term land protection and much more."

The final relicensing agreement is expected to closely mirror the Agreement in Principle (AIP) released in August 2006. During the past several months, negotiation participants have been hammering out final language that adds more detail to the agreement.

Record catfish caught at Badin Lake

There's a monster blue catfish out there in Badin Lake.

Eric Fincher of Mount Pleasant knows it, because he caught and released the record-breaking catfish, certified at 89 pounds and four feet, four inches long, in the Stanly and Montgomery counties reservoir.

"I brought him in and pretty much went into shock," Fincher said. "He was too big for the net, but I told my wife I had to get him in the boat, he was a record setter. And somehow, we did."

Unable to find certified scales that afternoon, Fincher took the giant blue catfish to his father-in-law's house, where he made a makeshift holding tank by damming a nearby creek. That was Nov. 25.

On Nov. 27, certified scales were located and Lawrence Dorsey, a fisheries biologist with the Wildlife Resources Commission, was on hand to make things official. Fincher used an Eagle Claw medium rod with an Abu Garcia 6500 reel, fishing a live shiner at 18 feet in a 43-foot depth, on 15-pound test line, while trolling for striped bass.

"The next day, Nov. 28, I took him back to the lake and he swam right off," Fincher said. "I'm confident he's still in

Alcoa urges U.S. government to reduce greenhouse gas emissions

Alcoa has joined nine highly esteemed U.S.-based companies and four leading environmental organizations to call on the U. S. government to quickly enact strong national legislation to achieve significant reductions of greenhouse gas emissions.



Alcoa is a founding member of the U.S. Climate Action Partnership, a group formed to send a clear signal to lawmakers that legislative action is urgently needed.

"Each year that we delay action to control emissions increases the risk of unavoidable consequences that could necessitate even steeper reductions in the future, at potentially greater economic cost and social disruption," said Alcoa Chairman and CEO Alain Belda. Belda represented Alcoa at congressional and national press briefings introducing the U.S. Climate Action Partnership on January 22, 2007.

The group believes that U.S. policy must include mandatory approaches to reduce greenhouse gas emissions from economic sectors with the highest emissions; flexible

To qualify for a state record, anglers must have caught their fish on a hook and line, must have their fish weighed on a certified scale witnessed by one observer, have the fish positively identified by a qualified expert from the Commission and submit an application with a full, side-view photo of the fish.
