Community update



During these uncertain times Alcoa remains committed to safeguarding our people and doing what we can to minimise any impact of COVID-19 on communities close to where we operate.

With appropriate protocols in place to protect our workforce, suppliers, contractors and community, work is continuing onsite.

Mine rehabilitation works

Following the completion of the major earthworks in the mine last month, the hydroseeding of the native grassland on the south wall is now more than 50 per cent complete.

Specialised contractors are laying coarse sand and compost to prepare the surface before spraying wood fibre mulch and grass seed onto the area. The works have been hampered by recent wet weather and are now expected to be completed next month.

A temporary fence has been constructed around the grasslands area to keep grazing animals, particularly kangaroos, away from the grass as it matures over the next two to three years.

Mine water filling strategy

As outlined in our April and May updates, Alcoa has made an application to Southern Rural Water to conduct a 12-month groundwater pumping test as a source of water to commence the mine void filling process.

Alcoa has an existing licence to pump 4 gigalitres a year from the Upper Eastern View aquifer and is required to apply for a licence amendment to enable the water to be used in the mine void. During power station operations we used around 3.5 gigalitres per year, however during the test only approximately 1.5 gigalitres in total would be extracted. The test, that we aim to start in coming months, would include extensive monitoring and key stakeholder and community reporting.

Our strategy is that the 12-month test will provide additional information to Alcoa, the regulators and the community to better inform us all about the potential use of the groundwater in the longer term.

Coalmine Road

Work on the Coalmine Road relocation activity - the final preparation of the subsurface prior to crushed rock and sealing - is nearing completion.

Wet weather has also delayed these works, however we should have them complete during July, weather permitting.

Once completed and signed off by the Surf Coast Shire, temporary fencing will be removed. The shire, Parks Victoria and the Victorian Government's Earth Resources Regulation will then determine when the road will be reopened to the public for vehicles, cyclists and pedestrians.

Weeding

An extensive weeding program to remove invasive vegetation species is underway in and around the mine rehabilitation area.

Locally experienced contractors are conducting the work to identify and remove or treat weeds.

To date more than 70 hectares has been completed. In the second half of the year the program will be expanded to the power station and surrounding lease area. Unfortunately, the COVID-19 restrictions have meant the cancellation of our April and June Community Consultation Network meetings, but we will continue to keep you informed with monthly updates and opportunities for online feedback.
